assign an available DJ best suited for the event. If by unavoidable circumstance, your scheduled DJ Personality is not able to perform on the date of your event,

(1) Performance facility provides DJ with a sturdy covered table approximately 2 x 8 feet in an area within 25 feet of a 110-volt outlet (3 prong grounded);
(2) Facility is open at least one hour prior to scheduled start time; (3) Facility meets all federal and state safety regulations and has all appropriate music
licenses and performance permits; (4) Reasonable steps will be taken to protect DJ Foe Life Mobile Services equipment, personnel, and music, and crowd
control will be provided if warranted; (5) For outdoor performances, shelter is provided that completely cover and protects DJ Foe Life Mobile Services
equipment from adverse weather conditions. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to
comply with these provisions. In the event of circumstances deemed by DJ to present a real or implied threat of injury or harm to DJ, equipment, or recordings,
then DJ reserves the right to cease performance until such time as the client resolves the threatening situation. DJ further reserves the right to deny any guest
access to recordings or equipment. In the unlikely event the DJ's performance is delayed, liability is limited to providing client with performance time equal to time
